7. Update on the 2022 OACP Annual Training Conference. (Steve Whitlock)

11. Update on the Oklahoma Law Enforcement Accreditation Program (OLEAP). (Kevin McCullough)

As of April 20th, we have 197 agencies that are compliant with Executive Order No. 13929. We now have 16 agencies that have been accredited, 5 agencies that are certified, and 26 agencies that are verified.

12. Executive Director's Report.

Director Whitlock said the vests that were donated to OACP have been used to provide two departments with vests for all their officer. General Meeting will be May 12, 2022, at Moore Norman Vo-tech.
